Statistics Request Overall Description

On Friday, July 8, 2022, Andrea Bruns requested from Research and Statistics a report of the number of dependency, neglect and abuse (DNA) cases filed in calendar year 2022 (CY22) with an OCASA document or CASA party type entered with totals of each indicator reported for DNA cases in each county. Demographic data was also requested.

The CourtNet database, which provides a summary of cases statewide, was queried for cases filed statewide from 1/1/2022 through 12/31/2022 with a case type code of Child Abuse/Neglect (CA), Child Abuse (CHA), Neglect (NEG), or Dependency (DEP) containing a document type code of OCASA - Order Appointing CASA or a party type of CASA - Court Appointed Special Advocate and for race/ethnicity and gender entered within the case.

Statistical Report 21_RS2018

Statistical report 21_RS2018 provides a count of dependency, neglect, and abuse cases filed during CY22:

Pages 1-8: Provide a count of dependency, neglect and abuse cases filed with document type code of OCASA or party type of CASA entered. The data is organized by county and case type with counts and percentages provided for cases with OCASA or party type of CASA entered and totals for each.

Pages 9-22: Provide a count of race/ethnicity of the child entered dependency, neglect and abuse cases filed and is organized by case type and county.
